This is a recap of the Police Productivity, Proactive and Reactive call responses. Week s 42 and 43 of the Lake Vista Crime Prevention Detail, January 21st — February 3rd, 2019.

<u>January 21, 2019/ #14 Wren/11:41 p.m.</u> – Ofc. Faust receives a dispatched request for an escort at this residential location.

<u>January 23, 2019/#105 Lark/5:53 p.m</u> – Ofc. Zink receives a dispatched request for an escort at this residential location.

<u>January 27, 2019/# 34 Egret/ 1:05 a.m.</u> – Sgt. Duplessis was dispatched to an ADT Alarm notification at this residence. Sgt. Duplessis checked the perimeter of this location finding no forced entry, no damage. Reported that the residence was secure and advised dispatch accordingly.

<u>January 27, 2019/320 W. R.E. Lee/1:10 a.m.</u>. – Sgt. Duplessis specifically assisted NOPD on this dispatched call for assistance. 911 Call came out as "several male subjects pulling on car door handles" on vehicles in the area. As NOPD asked for back-up and assistance, these subjects fled ensuing pursuit. NOPD relayed information that the suspect's vehicle crashed during the pursuit. Final disposition and report to NOPD.

<u>January 28, 2019/Elysian Fields and Lakeshore/9:01 p.m</u>. – Although not in the Lake Vista area, Ofc. Zink left the Lake Vista Detail to refuel his police unit. He witnessed a (1) vehicle crash at the above location. Concerned for the occupants he stopped to assist. He identified that the driver and the passenger were injured. Ofc. Zink stayed on scene until EMS and NOFD arrived to formally assist. (This activity is noted for the time frame that this officer was not on assigned patrol.)

<u>January 28, 2019/Marconi @ Stilt/11:16 p.m.</u> – Ofc. White receives a dispatched call of dark colored suspicious vehicle. Upon arrival he verifies that the driver is contracted through Uber. Since the driver does not have his client inside, Ofc. White checks the driver through criminal history records. No further police action was warranted.

<u>January 29, 2019/#14 Wren/12:03 a.m.</u> – Ofc. White receives a dispatched request for an escort at this residential location.

<u>January 31, 2019/#105 Lark/6:15 p.m</u>. – Ofc. Gerhold receives a dispatched call for an escort at this residential location.

<u>January 31, 2019/#77 Thrasher/11:14 p.m</u>. – Sgt. Duplessis finds a purse laying in the middle of the street. He identifies the owner at #77 Thrasher. Upon contact, the resident advises she did not lock her vehicle and her purse was gone. Sgt. Duplessis positively identified this subject as the owner of the purse. NOPD and EJLD Dispatch are notified. NOPD District Investigative Unit is called to the scene to file the official report.

<u>January 31, 2019/#97 Wren/10:27 p.m.</u> – Sgt. Duplessis responded to a dispatched call of (2) subjects seen by the resident near her car, on her camera system. Upon arrival, the resident stated she turned on her exterior lights, which were not on previously. Upon doing so, the subjects fled. Sgt. Duplessis checked her vehicle and observed no forced entry and no damage to the resident's vehicle. Sgt. Duplessis notified OLDP and NOPD of the information given by the resident and then patrolled the area intensively, but found no suspicious persons on foot or vehicles moving in the surrounding area.

<u>February 5th, 2019/#81 Oriole/4:42 p.m</u>. – Ofc. Gerhold responded to a Dispatched 911 Call concerning a Medical Emergency. Upon arrival, Ofc. Gerhold identified a female resident unresponsive, CPR was initiated. As NOFD and NO/EMS arrived on scene, the female in question was pronounced deceased on the scene. New Orleans Coroner's Office has the case and is performing a follow up investigation on this incident.

<u>February 5th, 2019/#14 Wren/12:00 a.m</u>. – Ofc. Faust performed a Requested Escort for the resident at this location.

<u>February 6th, 2019/105 Lark/6:00 p.m.</u> – Ofc. Zink performed a Requested Escort for the resident at this location.

<u>February 7th, 2019/# 4 Ani/5:55 p.m.</u> – Capt. Yetta assisted OLDP Units with a Suspicious Person Call at this location. Resident had video of a B/M subject in the rear of the residence. Upon arrival the suspect could not be located. Video evidence turned over to the NOPD 3rd District Detective Unit for investigation.

<u>February 9th, 2019/ Gull and R.E.Lee/ 5:30 p.m.</u> – Capt. Yetta was flagged down by a resident who wished be named anonymous, concerning "magazine solicitation" in Lake Vista. Capt. Yetta and OLDP Units canvassed the area and found subjects fitting this description in the middle of Egret Street. Subjects were informed without a municipal permit, they would have to cease operations in the area.

<u>February 11th, 2019/#14 Egret/11:47 p.m</u>. – Ofc. White performed a Requested Escort for the resident at this location.

<u>February 11th, 2019/#11 Rail/ 12:45 a.m</u>. – Sgt. Duplessis responded to an ADT Burglar Alarm set off with the resident still inside the premises. Upon arrival, Sgt. Duplessis made contact with an elderly female occupant who stated she "heard voices" in her house. The property was thoroughly checked with no suspicious persons inside.

Although this is a Civil Litigation request in nature, Ofc. Canfield relays the information to the Lake Vista Security Detail Officers and advises OLDP Personnel.

<u>February 15, 2019/Wren@ S. Wren/11:09 p.m</u>. – Ofc. Canfield intercepted a dispatched call of a Black Suspicious Vehicle driving slow in the area. As Ofc. Canfield made contact with this vehicle, it was learned that this was an UBER driver.
