**This is a recap of the Police Productivity, Proactive and Reactive call responses. Weeks 43 and 44 of the Lake Vista Crime Prevention Detail, February 4th – 11th , 2019.**

**February 5<sup>th</sup>, 2019/#81 Oriole/4:42 p.m.** – Ofc. Gerhold responded to a Dispatched 911 Call concerning a Medical Emergency. Upon arrival, Ofc. Gerhold identified a female resident unresponsive, CPR was initiated. As NOFD and NO/EMS arrived on scene, the female in question was pronounced deceased on the scene. New Orleans Coroner's Office has the case and is performing a follow up investigation on this incident.

**February 5<sup>th</sup>, 2019/#14 Wren/12:00 a.m.** – Ofc. Faust performed a Requested Escort for the resident at this location.

**February 6<sup>th</sup>, 2019/105 Lark/6:00 p.m.** – Ofc. Zink performed a Requested Escort for the resident at this location.

**February 7<sup>th</sup>, 2019/# 4 Ani/5:55 p.m.** – Capt. Yetta assisted OLDP Units with a Suspicious Person Call at this location. Resident had video of a B/M subject in the rear of the residence. Upon arrival the suspect could not be located. Video evidence turned over to the NOPD 3<sup>rd</sup> District Detective Unit for investigation.

**February 9<sup>th</sup>, 2019/ Gull and R.E.Lee/ 5:30 p.m.** – Capt. Yetta was flagged down by a resident who wished be named anonymous, concerning "magazine solicitation" in Lake Vista. Capt. Subjects were informed without a municipal permit, they would have to cease operations in the area.

Canfield if flagged down by a neighbor, unidentified at the location, concerned that no one has been home at this location and the property seems abandoned. Ofc. Canfield confirms the property is up for sale and the residents moved out weeks ago.
